Arkansas State University Board of Trustees March 6, 2009

The Arkansas State University Board of Trustees met on March 6, 2009, in the

Workforce Training Room of the Technology East Building on the Searcy campus.

Mrs. Florine Milligan, Vice Chair of the Board of Trustees, called the meeting to order at

10:02 a.m. Board members present were: Mrs. Florine Milligan, Mr. Howard Slinkard,

Mr. Ron Rhodes, and Mr. Mike Gibson. Mr. Mike Medlock was absent due to illness.

Dr. Rockey E. Starnes, pastor of St. Paul United Methodist Church, delivered the

invocation.

Minutes:

Upon motion by Mr. Slinkard, second by Mr. Gibson, the minutes of December 12,

2008, were approved.

Mr. Don Harlan, vice chancellor for Workforce and Economic Development of ASU-

Searcy welcomed everyone to the campus. He gave a brief history of the campus along

with a schedule of events for the afternoon building dedication ceremony and open house.

Campus Reports

System - Dr. Les Wyatt, President

As part of the federal economic stimulus initiatives, several funding measures have

been introduced that may have an impact on higher education. All campuses have

put forward considerations for distribution from those funds. Budgets have been

developed and approved for the remainder of the fiscal year. Two of the five

two-year schools in Arkansas to receive funding from the federal continuing resolution were within the ASU System. Credit was given to the work of Senators Mark Pryor and Blanche Lincoln and Congressman Marion Berry in bringing attention to the issues confronting ASU.

- The January ice storm affected the Jonesboro, Newport, and Mountain Home campuses. Campus leadership came together to provide a safe, secure environment for faculty, staff, and students and provided assistance to the communities they serve.
- Higher education was included in the Governor's balanced budget proposal that would provide funding within the revenues available to all the state agencies. None of the institutions of higher education will receive much of an increase in appropriations in the coming biennium. The campuses will have minimal tuition and fee increases, if any at all. At the beginning of the next biennium, a change in procedure will be made that will allow the Legislature to have an opportunity to consider appropriations annually.
- Several bills have been introduced to create new statutes. One such bill was the transfer bill introduced by Representative Mike Burris. This bill will have a significant impact on the transfer between the two- and four-year campuses within the state. A meeting of the chief academic officers of all ASU campuses will be held following the board meeting to discuss the best response to this bill. The goal will be to make the transfer process between the two- and four-year campuses as seamless for the students as possible.

ASU-Newport - Chancellor Larry Williams

- Enrollment for the spring semester is 1,879 students. This represents a 36% overall enrollment increase and a 13% increase on the Newport campus alone.
 Additional information distributed contained information by institution within the state related to the fall term student headcount, unduplicated headcount, FTE enrollment, and composite information relating to student demographic profiles.
- The Workforce Training Consortium Board in Jonesboro has committed \$151,000
 to purchase the Mechatronics system that will be needed to implement the
 Manufacturing Technology program at the ASU Technical Center in Jonesboro.
- The Transportation Technology Center at Newport as well as the project on the Marked Tree campus will be completed this month. The construction on the campus of the ASU Technical Center in Jonesboro should be completed in July.
- ASU-Newport was one of three two-year colleges in Arkansas recognized as a
 United States Presidential Community Service Award winner. This was their
 second consecutive year to receive this honor.
- On March 31, there will be a dinner to recognize donors to the ASUN Capital
 Campaign. In addition, a ribbon cutting ceremony will be held on April 2 for the
 Transportation Technology Center.

ASU-Mountain Home - Chancellor Ed Coulter

- Spring enrollment set a record at 1,305 students, which is a 6% increase in headcount and an 8.5% increase in FTE.
- The campus landscape sustained major losses during the ice storm. One estimate
 of \$480,000 was received. However, the ASUMH staff assisted by inmates from
 the North Central Correctional Facility at Calico Rock worked to clear and restore

the grounds. Within 24 hours, faculty and staff had notified students taking on-line classes that adjustments would be made for course work when electrical power was restored. Additional funds are needed to continue construction of the Vada Sheid Community Development Center. The current contract is for \$12 million with an expected completion date of summer 2009. The federal stimulus bill does not allow funding for new construction. Approximately \$2 million of the total \$4 million needed to complete the building has been raised. Credit was given to the efforts of Congressman Marion Berry and Senators Blanche Lincoln and Mark Pryor in securing these funds.

- College Goal Sunday was a success with double the number of participants over last year's event.
- Over 49% of eligible employees have signed up for the Blue and You Fitness
 Challenge.
- A Trout Resource Center is being proposed to be included in the Vada Sheid
 Community Development Center. The center will be a museum/education entity
 emphasizing water resources and a trout hall of fame. This project has the support
 of a number of well-known individuals in outdoor sports.

ASU-Beebe – Ms. Stephanie Nichols, Assistant to the Chancellor

Chancellor Eugene McKay was attending an exit interview with an accreditation team for the Veterinary Technology program.

 Graduation will be held on April 30 for students receiving technical certificates and certificates of proficiency. On May 1, Jonesboro bachelors and masters degrees will be presented with Attorney General Dustin McDaniel as speaker. ASU-Heber Springs' graduation is scheduled for May 2.

- A wellness program has begun for all ASU-Beebe campuses to encourage employees to become more physically fit. In an effort to promote wellness, on June 1, 2009, ASU-Beebe will become a tobacco-free campus.
- A search will begin in April for a vice chancellor for ASU-Heber Springs. Chris
 Boyett will serve as interim vice chancellor.
- Beebe is a member of the Arkansas Association of Two-Year Colleges Aviation
 Training Consortium. This consortium received a \$2.9 million federal grant to train
 employees for the Arkansas aviation industry.

ASU-Jonesboro – Chancellor Robert Potts

- A project has been submitted to the Arkansas Department of Higher Education for stimulus funding. The proposal was to modernize, renovate/repair facilities that are used in instruction, research, and student housing, which would include lighting, retrofits, mechanical systems upgrades, technology, and instructional upgrades in classrooms, labs, and buildings.
- An \$86.8 million project list was developed by Jonesboro campus administrators
 for submission to the ADHE in anticipation of stimulus funding.
- An invitation was extended to all to attend a centennial celebration event on
 April 1. This date marks the actual day of the signing of Act 100 which created
 Arkansas State University and three sister institutions. Dr. Ruth Hawkins and the
 Centennial Commission have a number of special events planned for that day.

Dr. Wyatt explained that ASU has had property management of the Arkansas Services Center located in Jonesboro for 40 years. The lease is now expiring and the resolution will allow the transfer of the facility and all of the liabilities to be returned to the State of Arkansas. Resolution 09-02 is a formal approval of a System Internal Audit Charter necessary to comply with the standards required by the Institute of Internal Auditors. Resolution 09-03 addresses the current policy for educational privileges and tuition discounts for employees and their dependents. The policy is silent with respect to extension of these privileges to the trustees. The proposed resolution will restrict the application of the policy to members of the Board of Trustees.

ACTION ITEM:

Arkansas State University System (ASU System) requests authority to transfer the property management of the Arkansas Services Center (ASC) to the State of Arkansas.

ISSUE:

Arkansas State University-Jonesboro (ASUJ) has managed the Arkansas Services Center for 40 years. The original financing will be paid off on September 30, 2009 and ASUJ will no longer have the legal responsibility to serve as the on-site property manager.

BACKGROUND:

- Arkansas State College acquired 117 acres of land located in Craighead County. The property is now defined by Brown's Lane on the west, Race Street on the north, Frontage Road on the south, and private acreages adjoining the property on the east (see Attachment).
- The State of Arkansas had several service units that required building space in the Jonesboro area; however,
 the state did not have the capital with which to build a new building, nor did adequate office space exist in the
 Jonesboro market for lease. Consequently, the Board of Trustees of the Arkansas State College was asked to
 use its bonding authority to construct the state facility on a portion of the acreage. The final design of the
 building included 156,570 square feet.
- The Board of Trustees issued bonds in the amount of \$2,250,000 at an interest rate of 4.5% for 40 years. The final maturity of the bonds is October 1, 2009. The board required financial sureties from the state agencies and protected its financial position by having the state agencies sign leases that spanned the length of the financing. ASU further protected its financial exposure by requiring the state agencies to assign the property management oversight to Arkansas State College until the bonds were paid and the leases expired.
- ASUJ has been managing the Arkansas Services Center since its construction completion in 1968. The
 current state agencies leasing space in the ASC and their ownership interests pursuant to the leases are as
 follows:

- Once the bonds are paid, the state agencies may exercise their ownership rights by paying one dollar. The
 state agencies have all expressed the desire to exercise their ownership options, and the building will be
 owned by the State of Arkansas on October 1, 2009, or the payoff date of the bonds. Consequently, the
 property management responsibilities should also transfer from ASUJ to the state agency responsible for
 managing state property, or the Arkansas Building Authority (ABA).
- ABA has requested a state appropriation for the 09-11 Biennium to assist with the management of the
 property. ASUJ and ABA will formally transition the property management from the date of approval of the
 Board of Trustees until the bond payoff date of September 30, 2009.
- All of the maintenance employees are currently employees of Arkansas State University; however, they were
 notified approximately one year ago that they may transfer to other ASUJ vacant positions with similar titles,
 or remain employees of the state by transferring to employment under ABA.

RECOMMENDATION/RESOLUTION:

Be it resolved that the Arkansas State University System is approved to transfer the property management responsibilities for the Arkansas Services Center from Arkansas State University-Jonesboro to the Arkansas Building Authority, a division of the Arkansas Department of Finance and Administration effective October 1, 2009.

ISSUE:

The Institute of Internal Auditor's (IIA) International Standards for the

Professional Practice of Internal Auditing (Standards) requires that institutions

have an Internal Audit Charter approved by the board.

BACKGROUND:

• The Internal Audit function for Arkansas State University was transferred to the ASU System from the Arkansas State University-Jonesboro campus effective January 1, 2008.

- The ASU System Internal Audit mission is to "support the campuses of the ASU System in the pursuit
 of their mission by evaluating the adequacy of internal controls, accuracy of financial records, and
 compliance with standard accounting practices, government and state regulations, and university
 policies and procedures."
- The Internal Audit function will review accounts and procedures on all of the ASU System campuses.
- The standards require that institutions have an Internal Audit Charter approved by the board.
- By approving the attached charter, the Board of Trustees provides the President and Internal Audit staff with the authority to conduct audits on all of the ASU System campuses.

RECOMMENDATION/RESOLUTION:

Be it resolved that the Arkansas State University Board of Trustees approves the Arkansas State University System's Internal Audit Charter, effective March 6, 2009.

Arkansas State University System

Internal Audit Charter

INTRODUCTION

The Arkansas State University System (ASU System) Internal Audit function performs an independent appraisal activity for the review of internal controls, financial and compliance aspects, and operating procedures as a service to the Board of Trustees and university administrators.

PURPOSE

The Internal Audit function is a continuous independent management control and appraisal activity established within the university to review accounting, financial and other operations to determine for the ASU System President and Board of Trustees that:

- 1. Assets are safeguarded and their use is properly accounted for;
- 2. Accurate financial and managerial control exist and function properly;
- 3. Recommendations are made for appropriate improvements in controls; and
- 4. Management plans, policies and procedures are carried out and executed efficiently and effectively.

ORGANIZATION

The coordination of the ASU System's internal auditing function is the responsibility of the Assistant Vice President for Administration (AVPA). The AVPA operates under the general administrative oversight of the Vice President for System Operations (VP) and reports to the ASU System President. The VP is assigned responsibility for the day-to-day operation of the internal audit program to provide support and supervision of Internal Audit and to assure the adequacy of the management responses to audit reports issued by the AVPA and follow-up on audit issues.

AUTHORITY

The ASU System Internal Audit staff is authorized full, free, and unrestricted access to all university functions, records, property, and personnel relevant to the subject under review within the entire ASU System. Documents and information given to the Internal Audit staff during an engagement are handled in the same prudent manner as by those employees normally accountable for them. The confidential and privileged character of the documents and information is not affected solely by disclosure to the audit staff.

Internal Audit has neither direct responsibility for, nor authority over, any of the activities, functions, or tasks it reviews. Accordingly, Internal Audit does not develop or write policies or procedures that they may be later called upon to evaluate. Draft materials, developed by management, may be reviewed for propriety and/or completeness. However, ownership and responsibility for any materials remains with management.

Acting in the capacity of an Internal Auditor, audit staff should not perform any operational duties for the ASU System or its affiliates, initiate or approve accounting transactions external to Internal Audit, or direct the activities of any ASU System employee not employed by Internal Audit, except to the extent such employees have been assigned to otherwise assist the internal auditors.

RESPONSIBILITY

Meaningful internal auditing requires cooperation among the Internal Auditors, campus administration, and the auditee. Each party's responsibilities in this regard include but are not limited to the following:

AVPA:

- Develop a flexible annual audit plan using an appropriate risk-based methodology, including any risks or control concerns identified by management, and submit that plan to the ASU System President and VP.
- Implement the annual audit plan, as approved, including as appropriate any special tasks or projects requested by management or the Board of Trustees.
- Maintain a professional audit staff with sufficient knowledge, skills, and experience.
- Issue periodic reports summarizing results of audit activities to the ASU System President, with copies sent to the Chair of the Board of Trustees, and the VP.
- Perform investigations of suspected fraudulent activities within the ASU System and notify the ASU System President of the results with copies given to the Chair of the Board of Trustees, VP, and appropriate members of campus management.
- Consider the scope of work of external auditors and other regulatory agencies, as appropriate, for the purpose of providing optimal audit coverage to the ASU System at a reasonable overall cost.

Internal Audit Office:

- Examine and evaluate the controls, policies and procedures, and systems in place to safeguard university assets:
- Evaluate the reliability and integrity of information and the efficient and effective use of resources;
- Review compliance with policies, procedures, laws and regulations; and
- Report results and make recommendations to the AVPA and management.

Administration

- Support the Internal Audit function and communicate this support within campus units;
- Participate in the audit process;
- Provide appropriate, clear and consistent direction to the college community through written policies and procedures; and
- Follow-up on progress of corrective actions for audit findings within campus units.

Auditee

- Cooperate with the audit process by providing unrestricted access to facilities, books and records, information, and personnel.
- Respond in writing, within 30 days, to all audit recommendations. Disagreements with recommendations
 or alternative solutions to identified findings are acceptable when justified in writing. Each response
 should contain an estimated implementation date.
- Implement agreed-upon corrective action plans.

AUDIT PLANNING

An annual audit plan, based on a risk assessment process, will be systematically developed for the ASU System as a whole. The risk assessment shall consider risks within and across all components of the ASU System. Input will be solicited from the appropriate members of management at each respective campus for this purpose. Once completed, the audit plan will be submitted to the VP and ASU System President for comment and approval. The objective is to continually assess all high-risk areas of the ASU System and to evaluate critical business processes throughout the ASU System as resources permit.

When special projects are requested by campus management, the AAVP shall notify the Vice President for ASU System Operations. When demands for services exceed available resources that would significantly impact the approved annual audit plan, project priorities will be established and the audit plan amended subject to the approval of the VP, or if the changes to the plan are substantial, the ASU System President.

REPORTING

Internal Audit will ensure the results of audits are properly communicated to appropriate management or operating personnel in a formal written report to the ASU System President under the signature of the AVPA. Management's responses to the audit observation(s) will be incorporated into the formal report and will itemize specific actions taken or planned to resolve the reported observation(s) or to ensure operational objectives are achieved.

Copies of completed audit reports will be provided to the Chair of the Board of Trustees, the VP, and appropriate members of campus management.

Internal Audit will produce a follow-up report on the status of management's implementation of each observation to the VP on a quarterly basis.

AUDIT STANDARDS AND ETHICS

Internal Audit staff members shall subscribe to and comply with the Standards for the Professional Practice of Internal Auditing and Code of Ethics promulgated by the Institute of Internal Auditors, Inc. and the Government Auditing Standards by the Comptroller General of the United States. The department is expected to consistently demonstrate high standards of conduct and ethics as well as appropriate judgment, independence, and discretion. Members maintain a professional image and protect auditee confidences and confidential information.

ACTION ITEM:

Arkansas State University System desires to establish that the current

educational privileges policy provided to Arkansas State University employees

does not apply to members of the Board of Trustees.

ISSUE:

Arkansas State University regular, full time employees, retired employees, their spouses and unmarried dependent children are afforded educational discounts for tuition. The policy is silent as to whether such benefits are available to members

of the Board of Trustees.

BACKGROUND:

- Current Arkansas State University System policy affords regular, full time employees, retired employees, their spouses and their unmarried dependent children the privilege of enrolling for undergraduate studies on a space-available basis at a 75% discount of tuition and for graduate studies on a space-available basis at a 50% discount of tuition.
- The policy is silent as to whether educational privileges by way of tuition discounts are available to members of the Board of Trustees.

 20% of the Foundation Grant or \$2,901,668 from other sources to be held by the Arkansas State
 University Foundation pursuant to the Construction Grant Agreement and the Restricted Fund
 Agreement entered into on July 27, 2007. The funds so raised and held are to be used for building
 maintenance and repair of the Donald W. Reynolds Center for Health Sciences.
- According to the Construction Grant Agreement and the Restricted Fund Agreement, the building may not be occupied until all the matching funds are received or pledged.
- There is \$1,901,668 which must be raised, pledged, or otherwise set aside in order for the building to be dedicated, occupied, and used upon its completion during the summer 2009.
- The Donald W. Reynolds Foundation has agreed to allow \$1,901,668 to be set aside in a Restricted Fund for Building Maintenance within Arkansas State University-Jonesboro from current reserves as more fully shown on the agreement attached as Exhibit A.

The two higher education institutions seek to expand their relationship to make the Bachelor of Science in Dental Hygiene program accessible to students in northern Arkansas. The four-year program offering will be funded from monies available through the AHEC North Central. The agreement will be formalized with a memorandum of understanding covering specifics for both curriculum requirements and financial aid. ASUMH will provide the general education requirements of the degree, with UAMS providing the professional coursework via distance technology. The clinical portion of the program will be offered through the Mountain Home Christian Clinic.
