acknowledge a major gift from Jim and Jill Gaston.

ISSUE: The Board of Trustees must approve all names given to buildings

and areas on the Arkansas State University campuses.

## **BACKGROUND**:

Arkansas State University-Mountain Home is preparing to build a Community Development Center. The Center will contain an auditorium, a banquet hall, a cultural arts center, the BIWD (Business, Industry, and Workforce Development) program, the adult education program, and the center for advanced studies. Jim and Jill Gaston propose to contract with the ASU Foundation to give \$100,000 in stocks to the ASU Foundation at this time, and to pledge to give \$100,000 in stocks or cash within 24 months of the first gift to secure this naming opportunity in honor of their friend, Senator Dale Bumpers.
