The Arkansas State University Board of Trustees met by telephone conference

call on Monday, June 14, 2004, in the conference room of the President's Office on the

Jonesboro campus. Mr. Mike Medlock, Chair of the Board of Trustees, was present and

called the meeting to order at 3:04 p.m. A telephone roll call confirmed the presence of

Mr. Medlock moved to the first item on the Consent Agenda:

explaining that during the past six years the Jonesboro campus has developed two

doctoral programs of significance to the university. These are capstone doctorates as

they incorporate a number of undergraduate and master's level courses that make up

the doctoral levels. Because of the strong student demand for a master's level offerings

while working toward a PhD, the university will use existing courses and faculty to

package master's level courses.

Dr. Wyatt explained that this resolution and the one which follows requires full Board approval prior to application because of changes in the guidelines published by the Reynolds Foundation. ASU-Beebe will apply for a grant for an Aquarium and Science Center that will cost approximately \$13,761,400 with a total of 67,473 sq. feet. ASU-Newport will propose a grant to create a Transportation Safety Center at a total estimated cost of \$5,200,000 with 24,000 sq. feet. Mr. Bell asked if there was any match in funding. Dr. Larry Williams, Chancellor of ASU-Newport, said if an applicant is successful a 20% match is required to be placed in an endowment for the operations and maintenance of the facility. Dr. Wyatt added that while the matching funds would be assured by the institution, each campus would responsible for those funds. For example, funds for the Newport project could be placed within from the ASU Foundation with restrictions to match the grant. Colonel Wood asked if 20% of \$13.7 million would place a strain on the Foundation. Dr. Williams responded by saying that the actual funding would be raised by each individual campus. Newport would need approximately \$1.4 million and this amount would be raised locally through other resources to be deposited into the Foundation. The Foundation itself would not be responsible for providing that match. Dr. Wyatt added the same would be true of the Beebe campus. Many campuses that received Reynolds' grants some years ago are still in the process of raising matching funds so adequate time is given by the Reynolds Foundation to raise the matching requirement. The ASU Foundation can hold funds and can sign off once the total match is accumulated.

<u>ISSUE:</u> The Board of Trustees must approve the offering of any new

degree or any new option of an existing degree prior to submission

to the Arkansas Higher Education Coordinating Board.

BACKGROUND:

The College of Engineering proposes establishment of an official minor in engineering. This will allow students in other technical majors such as physics, computer science, mathematics, chemistry, biological sciences, or agriculture to add to their formal educational credentials through completion of 23 credit hours of designated engineering course work; and also to solidify their background in particular areas of interest or specialization and acquire the computational, engineering science/analysis, and engineering design skills to augment the knowledge and skills gained in their primary major. Although the College of Engineering is in strong need of new faculty and other resources to support its primary mission of providing a competitive, marketable engineering education to its majors, the addition of this proposed minor will not, in itself, require any additional resources or course additions since the number of students initially pursuing the minor is expected to be relatively low (less than ten per year).

BACKGROUND:

The Ph.D. Program in Heritage Studies began operation in August 2001 after formal approval by the Arkansas Department of Higher Education. After a national search, Dr. Clyde A. Milner II became Director of the Heritage Studies Ph.D. Program on July 1, 2002. Academic year 2003-2004 is the third year of operation for the PH.D. Program. As of January 1, 2004, at least, 25 Ph.D. students will be enrolled in the program. It is anticipated that in academic year 2004-2005 approximately 30 doctoral students will be enrolled in the Heritage Studies Ph.D. Program. This proposal requests the creation of the Master of Arts in Heritage Studies which will only be available to students enrolled in the doctoral program. It will be an "en route" master's degree and not a separate master's program with a separate admissions process.

It has become evident that as the doctoral students progress through the Ph.D. curriculum, they should receive a master's degree. It is proposed that this M.A. in Heritage Studies be granted after the completion of all of the required course work in the Ph.D. program (36 semester credit hours, the equivalent of twelve 3-semester hour courses). Because the proposed "en route" Master of Arts in Heritage Studies will be fully contained within the already established Ph.D. Program in Heritage Studies, Arkansas State University will not need to provide additional faculty, facilities, library resources, or graduate courses beyond those that clearly must be provided for the doctoral program.

RECOMMENDATION/RESOLUTION:
