A Resolution Conferring Upon Governor Mike Beebe The Honorary Degree Doctor of Laws

WHEREAS, Governor Mike Beebe, has been duly nominated for an honorary doctorate from Arkansas State University-Jonesboro and his nomination has been properly reviewed and recommended by the Honorary Doctorate Committee, the Vice Chancellor for Research and Academic Affairs and the Chancellor of the University.

**NOW, THEREFORE BE IT RESOLVED**, by the Board of Trustees of Arkansas State University that Governor Mike Beebe shall be granted the honorary degree, Doctor of Laws, from Arkansas State University-Jonesboro which said degree shall be conferred during Commencement Exercises on May 5, 2007.
