#### **EXECUTIVE SUMMARY**

- **ACTION ITEM:** The Arkansas State University System requests approval to adopt and implement a Title IX policy that is compliant with applicable law.
- **ISSUE:** The Board of Trustees must approve modifications to ASU System policies.

#### **BACKGROUND:**

- Title IX is a comprehensive federal law prohibiting discrimination on the basis of sex by institutions of higher education that receive federal funds.
- The Arkansas State University System has maintained a policy prohibiting sexual discrimination in any
  program or activity and has also maintained a grievance procedure that complies with the
  requirements of Title IX.
- On August 12, 2020, the Board of Trustees approved a revised Title IX policy that is currently in effect today.
- On April 19, 2024, the U.S. Department of Education released revised regulations governing campus compliance with Title IX.
- Institutions of higher education were ordered to implement these new regulations on or before August 1, 2024.
- The revised Title IX regulations are being challenged in multiple courts across the United States. Some courts have issued injunctions prohibiting the new regulations from taking place in certain jurisdictions and for certain campuses. Currently, the Department of Education has been enjoined from enforcing the new Title IX regulations in the State of Arkansas.
- The ASU System must operate in compliance with applicable law.
- The ASU System Office will continue to monitor legal developments in the current Title IX litigation and ensure that the System's Title IX policies and procedures are legally compliant.
- Additionally, regardless of the outcome of the aforementioned Title IX litigation, the ASU System campuses will continue to utilize hearing panels to adjudicate Title IX claims. In order to ensure that

ACTION ITEM: The Arkansas State University System (the "ASU System") requests approval to accept the resignation of Cadence Bank (formerly BancorpSouth Bank) as trustee for certain housing bonds and to appoint a successor trustee.

**ISSUE:** The Board of Trustees of the ASU System (the "Board") must approve the appointment of a successor trustee.

#### **BACKGROUND:**

- Pursuant to a Trust Indenture, dated as of December 1, 2010, as supplemented by a First Supplemental Trust Indenture, dated as of March 1, 2012; a Second Supplemental Trust Indenture, dated as of December 1, 2012; a Third Supplemental Trust Indenture, dated as of March 1, 2013; a Fourth Supplemental Trust Indenture, dated as of November 17, 2016; a Fifth Supplemental Trust Indenture, dated as of December 20, 2017; a Sixth Supplemental Trust Indenture, dated as of December 18, 2019; and a Seventh Supplemental Trust Indenture, dated as of March 15, 2021 (collectively, the "Indenture"); between the Board and Cadence Bank (formerly BancorpSouth Bank), the following bonds have been issued for the benefit of Arkansas State University-Jonesboro and are currently outstanding: (a) Board of Trustees of Arkansas State University Housing System Revenue Refunding Bonds (Jonesboro Campus), Series 2013; (b) Board of Trustees of Arkansas State University Housing System Revenue Refunding Bonds (Jonesboro Campus), Series 2016; (c) Board of Trustees of Arkansas State University Housing System Revenue Refunding Bonds (Jonesboro Campus), Series 2017; (d) Board of Trustees of Arkansas State University Housing System Revenue Refunding Bonds (Jonesboro Campus), Taxable Series 2019; and (e) Board of Trustees of the Arkansas State University System Housing System Revenue Refunding Bonds (Jonesboro Campus), Taxable Series 2021 (collectively, the "Bonds").
- Cadence Bank (formerly BancorpSouth Bank) currently serves as trustee for the registered owners of the Bonds.
- Bank OZK has entered into an agreement to purchase the corporate and municipal bond trustee business of Cadence Bank, and Cadence Bank is resigning as trustee under the Indenture.
- The Board desires to appoint Bank OZK as successor trustee for the Bonds.

#### **BACKGROUND:**

- In March 2024, the Higher Learning Commission released information concerning the acceptance of applications for reduced credit-hour programs. Conversations with the Arkansas Division of Higher Education indicated that HSU may serve as the pilot program for the state of Arkansas.
- The proposed reduced credit-hour degrees can be completed in six (6) semesters. In addition to the 0 required courses listed for each degree, all students must complete the General Education Core Requirements, as specified by the University and required by the state.
- The proposed reduced credit-hour degrees do not replace the currently offered bachelor's degree in each • discipline. Therefore, no new faculty or courses will be required. With the expected growth, there will be further conversations about faculty resources needed to maintain sustainability in the future.
- The proposed reduced credit-hour degrees support the mission of the University by providing fundamental ۲ knowledge, concepts, and practical skills acquired through both study of concepts and theory. This knowledge is applicable immediately upon successful completion of the respective programs, for both immediate employment in the workforce and subsequent success in graduate school.
